#### THE NARRATIVE ESSAY

A narrative is defined as a story which centres on one event or a series of closely connected events. The main purpose of the narrative writer is to present or tell in detail a story that has one main point.

Simply put, a narrative essay is story-telling. Essentially, all narrative writing is concerned with *What happened*, and in telling what happened, story tellers concerned themselves with: **Setting, Characterisation, situation/conflict, action, climax and outcome**. These are the essential elements in narrative writing.

#### **Setting:**

Every story happens somewhere at some time. The time and place or the physical background of a story is its setting.

#### Characters

Characters are people who feature in a story. The leading character - the hero or the heroine - is also known as the **protagonist**. Usually there is an **antagonist** ... a character who stands against the wishes or the plans of the hero or the heroine.

## The Situation or Conflict

Something has to happen in a story and this cannot be unless the leading character has a problem or finds himself in a situation or conflict. This situation/conflict needs resolving.

### Action:

In resolving the problem or conflict, action comes in. The story then becomes a sequence of events following each other. This is called **plot**.

#### Climax

The action arising out of the situation continues until it reaches the point of highest interest, tension or excitement. This high point is known as **climax**.

#### **Outcome:**

After the climax has been reached, the situation/conflict is resolved. The outcome of the story is called **resolution**. It winds up the plot which consists of the situation, action, climax and outcome.

These are the essential elements in anything that tells what happened. The story may be simple or complicated, light or serious, sad or comic. Yet the elements of the narrative are always present. Remember to plan your story before you write it, basing your plan on the elements of narrative writing.

#### A GUIDE TO WRITING GOOD NARRATIVES

### Introduction

Make your introduction or opening of the essay catchy by launching directly into the story. Normally this will arouse the interest of your reader and encourage him to read the story. In contrast, a long and vague introduction will bore the reader and turn him off. Use the introduction to give background information and the conclusion to discuss the significance or personal impressions of the story. The bulk of the essay must however, be an account of exactly what happened.

#### Source of Material

If the scope of the question allows it, choose and write on an event which has an element of conflict. Experience has shown that conflict is the powerful tool for stories. You can develop in your narrative the following areas of conflict:

- Conflict of argument, decency, choices, struggle for victory, success or superiority between people.
- •Conflict within an individual resulting in his being torn between doing one of two or more things.
- •Conflict between an individual and forces of nature or the environment which may be beyond his control
- Conflict between an individual and his society emanating from his refusal to conform or do what everyone else does.

#### **Sustain Interest**

Having succeeded in arousing the interest of your reader through the use of an appropriate opening, do sustain it. This urges him on to read to the very last word. Here surprises, strange happenings and suspense will help but they should be natural and relevant to the atmosphere of the story. In short arouse curiosity and develop it to a logical end.

### Be Realistic

Realistic or true - to - life essays are more convincing and appealing than those depicting myth and fantasy. Where necessary mention names or create character, real life situations, places or setting in the narrative.

## **Time Sequence**

A story is a series of events and these should be arranged in their order of occurrence to the very last event or incident. Answer

### The 2007 Gubernatorial and Presidential Election

The House of Representative and Gubernational elections took place on the 21 of April 2007 while the Presidential election took place on the 14th of the same month. The two elections had been adjudged the worst elections Nigeria ever had and INEC, the Independent National Electoral Commission could not be exonerated from the charade. This election brought into power the Late Umaru Musa Yaradua as president and his cohorts of governors and parilamentarians.

The People's Democratic Party PDP, the ruling party in the country, made it difficult in several parts of the country for Nigerians to protect their electoral mandate. The citizens violated the law to accomplish their goal.

The 2007 House of Reps and Governorship elections took place under an ill-prepared and partial electoral commission. They were marred by reports of voters malfeasance and voterigging. In some areas of the country, polls opened either after significant delay or did not open at all. They were delayed supply of voters materials. Even though INEC concluded that the entire exercise was a huge success the majority of the national observers groups and international organizations concluded that INEC failed to deliver free and fair and credible elections.

The INEC preparation started early, nevertheless the entire process was shoddy and non-transparent. The voters registration was marred by complaints from the electorates and civil society groups. INEC introduced a Data capture machine to modernize the voters registration and to prevent multiple voting. Unfortunately the result of the excessive failed. The machines were faulty and insufficient as a result many Nigerian were disenfranchised. Some influential politicians harboured some machines in their houses to register votes illegally.

President Obasanjo then, made it clear that PDP must win the 2007 election by all means. This came to pass and PDP won the presidential, National and States Assembly and majorities of the Gubernatorial elections, but hundreds of Nigerians lost their lives for this to happen.

After the elections, the winners were announced without releasing the results of the election for Nigerians to see the details. So, many cases of rigging and electoral malpractice were recorded in all the states.

It is therefore worthwhile that for Nigeria's future elections to be credible, free and fair, a holistic review of all the defective provisions on electoral issues in Nigerian 1999 constitution and the 2006 Electoral Act must be revisited by the Nigerian legislature.

#### THE IRI JI FESTIVAL IN ORAUKWU

The New Yam Festival of the Igbo people (Iwa Ji) is an annual Igbo festival held at the end of the raining season in the early part of August each year. The Iwa ji festival literally "new yam eating" is practised by the Igbo's throughout West Africa (especially in Nigeria and Ghana) and other African countries symbolizing the conclusion of a harvest and the beginning of the next work cycle. The celebration is a very culturally based occasion, tying the individual Igbo community together as essentially agarian and dependent on yam.

The event prior to the day of the festival, all old yams (from previous year's harvest) are consumed or discarded. The next day, only dishes of the new yam are served as the festival is symbolic of the abundance of the produce,.

The role of eating the first yam is performed by the oldest man in the community or the king (Igwe). He also offers the yam to God, deities or ancestors. The rituals are meant to express gratitude of the community to the gods for making the harvest possible, and they are widely followed despite more modern changes due to the influence of Christianity.

The day is symbolic for enjoyment after the planting season and the abundance is shared with friends and well wishers. A variety of dance steps marks the eating of new yam. Folk dance, masquerades, parades and fun fare.

The iri ji festival is an occasion the Igbos look forward to each year.

#### THE ARGUMENTATIVE ESSAY

This essay involves the use of language persuasively, especially to win over the audience to one's view point. An Argumentative Essay topic has two sides to it - the topics are open to choice of either for or against. Some argumentative essay topics are given below:

- Write down arguments either for or against the proposition "Scientific Advancement Is a Curse to Mankind".
- Write a reasoned argument either for or against the motion "Television Has Done More Harm Than Good.

The argumentative essay may be roughly put under three categories

- For OR Against the motion/topic/proposition
- For AND Against the motion or topic
- The argument as a debate.

#### FOR OR AGAINST THE MOTION/TOPIC

You are offered a choice here. Examine the points for and against the topic and write on the side you think you can convincingly handle. Note that this is a one-sided argument and it should be written as such. Elsewhere this is known as the partisan method. The for or Against (Partisan method) can be structured in two ways.

### Method A

- A Begin with an introduction and use the last sentence to state your stand.
- B In the second paragraph you may bring in the opposing view (i.e. Those on the side you did not choose). A point or two will be enough here.
- C In the third paragraph you come round to refute (prove to be wrong) the assumptions as fallacies, the points raised in the second paragraph. This can be extended into two paragraphs.
- D In the paragraph or paragraphs that follow add or discuss points on the side you have chosen.
- E Use the last paragraph to conclude your essay by for instance re-stating the main points and emphasizing your stance.

### Also note the following

- Take a stand and stick to it. A candidate who writes on the two sides is throwing away precious marks.
- For a mark above the average, raise and develop about four points
- You earn credit for using persuasive language
- Ensure good paragraphing and logical sequencing of ideas.

#### Method B

You are not necessarily tied to using the structure (A to E) outlined above. Alternatively, you may avoid bringing in points on the opposing side. In other words, you can decide against raising points on the other side (which you will have to refute in the subsequent paragraphs). You can raise points which are all for or all against the topic.

#### **Question 1**

You have been invited to take part in an inter-school debate, the topic of which is: schooling in a village is more advantageous than schooling in a city. Write your speech for or against the motion.

### Answer

The Moderator, Panel of judges, Accurate Time Keeper, and my fellow-debaters, Good day I stand here today to refute the motion that "schooling in the village is more advantageous than schooling in the city. A village consists of small town located in a country side while a city is a large and important town where the population density is higher than that of a village.

Children attending school in the village face challenges of more abject poverty than those in the city. As a result, village schools have a hard time getting and retaining qualified teachers. No staff development due to salary and teaching conditions. Village teachers are less likely to receive health insurance and other fringe benefits. There is no gain-saying that students' achievement and teachers quality go hand in hand in most cases.

Village school students are not exposed to new technologies. For students to be successful they must be able to use these new technologies. Unfortunately village schools still find it difficult to provide the latest technological trend that students need to excel in school. #### **Question 2**

Answer

I propose the motion that "television is doing more harm than good to our Youths".

Let me start this debate by defining the key terms of the topic. By "television" I mean an electronic device that allows the broadcasting of audio and visual contents to an audience; in this debate also all the programs shown on this device, either through regular Channels or on cable, at any time of day or night. By "harm" I mean anything that outweighs whatever good effects there may be, and by "Youth" I mean all young television viewers.

I, in the affirmative, believe that television is doing much more harm to our youths than good and I will prove that to my attentive audience.

I will focus on two key arguments. TV has unacceptable levels of sex and violence that cause harm to our youths and is a significant tool of rampant commercialization which victimizes its viewers.
