A citizen is someone who is a member of a community, such as a city or town, state, or country. You are a citizen of Nigeria. Citizens are entitled to the rights and privileges that come with being a member of a country. In Nigeria as in other countries of the world, there are fundamental human rights. There are also rights of a child and some women. Sometimes the rights might be violated. It is very important for you to know your rights and ensure that they are not violated. As a citizen you also have some responsibilities. The way you handle your responsibilities as a citizen is known as citizenship.

MEANING OF RIGHT

A right is a statement showing the following

- i. A natural due
- ii. A moral claim
- iii. A legal entitlement

Right can also be called freedoms and benefits that are guaranteed to people by law.

FUNDAMENTAL RIGHTS OF EVERY NIGERIAN PERSON

Fundamental rights of every Nigerian person are the legal entitlements of each one of us .

1. Right to life: No one shall be deprived intentionally of his life
2. Right to dignity of human person : No one shall, for instance, be subjected to inhuman treatment.
3. Right to fair hearing :Every human person is entitled to fair hearing to a reasonable time.
4. Right to private and family life :The privacy of every Nigerian is guaranteed and protected.
5. Right to freedom of thoughts, conscience and religion:
6. Right to freedom of expression and press:Every Nigeria is free to express him/herself.
7. Right to peaceful assembly and association : Every person shall be entitled to assemble freely

and associate with other person.

8.Right to freedom of movement :Every Nigeria is entitled to move freely throughout Nigeria and to reside in any part thereof.

9.Right to freedom from discrimination :No citizen of Nigeria is expected to be discriminated against.

10.Right to acquire and own immovable properties anywhere in Nigeria.

Rights of a Nigerian child :

1.Right to life.

2.Right to health care.

3.Right to protection.

4.Right to communication.

5.Right to education.

6.Right to dignity. Etc.

7.Right to survive and develop.

Violation of rights :This is the act of depriving a person his /her rights or privileges.

Examples of human rights violation are:-

1.Kidnap.

2.Rape.

3.Human trafficking.

4.Killings.

5.Prostitution.
